E ghal aweewey kkapasal schóól-tarabwaagho me loll Form I-9, Employment Eligibility Verification me ówtol kkapasal me reel U.S. Department of Homeland Security me Social Security Administration rekod. Ngare e yoor mille ese weewe fengal, E-Verify ebwe aronga schóól-attarabwaagho me schóól-tarabwaagho bwe angaang-ló schagh nge ebwe bwal pipiiy me ghutta meeta ebwe fisch-ló probleemal.
