El aññe mel el e ko rejimwe, rijerbal eo emaroñ jerbal ilo United States. El aññe rejjab jejjet, E-Verify enaaj karoñ jikin jerbal eo innām rijerbal eo naaj kōrl ḥok an jerbal ilo an kajjeoñ kōtōprak jorrāān eo.

5. Kūrl ḥok Student im Exchange Visitor Program eo (SEVP).
