E-Verify ej juon internet-based system me jikin jerbal ko rej kōjerbale ṇan kaṃool employment eligibility an rijerbal kāāl ro. Ej keidi meḷ eḷle ko ikijjien Form I-9 eo an rijerbal eo, Employment Eligibility Verification, ṇan data jān U.S. Department of Homeland Security and Social Security Administration rekoot ko. Eḷ aṇṇe meḷ eḷ e ko rejimwe, rijerbal eo emaroṇ jerbal ilo United States. Eḷ aṇṇe rejjab jejjet, E-Verify enaaj karoṇ jikin jerbal eo innām rijerbal eo naaj kōrḷ ọk an jerbal ilo an kajjeoṇ kōtōprak jorrāan eo.

Kwaar bōk juon DHS Tentative Nonconfirmation (TNC) jān E-Verify kōn wōt immigration rekoot ko aṃ, me rej pād ilo DHS databases, remaroṇ jab jejjet. Kajimwi jekkar ko ilo immigration rekoot ko aṃ remaroṇ bōbrae DHS TNC's ilo tōre kaḷne rej itok. Eḷ aṇṇe ededeḷ ọk aṃ kōtōprak DHS TNC eo kar lewaj, komaroṇ kālōt ṇan wōnmaanḷ ọk wōt im bōk buṇtōn ko ṇan kajimwe immigration rekoot ko aṃ.
